



- **Magnumtuff India** is planning to take up new architectural & automotive glass processing unit in Hanchanala village, Hukkeri taluk, Belagavi district, Karnataka. The project involves establishment of architectural & automotive glass processing unit. The estimated cost of the project is Rs.465.8 million. As of January 2020, Karnataka's State Level Single Window Clearance Committee has approved the investment proposal.
- **Emerge Glass India** is planning to take up new container glass manufacturing project in Kothputli, Jaipur, Rajasthan. The project involves manufacturing of container glass with capacity 69350 Tonne. The company has filed industrial entrepreneurs' memorandum on November 2019. On February 2020, the project is in planning stage. As of December 2020, project involves manufacturing of sheet glass, figured glass and mirror with capacity 76550 Tonnes. The company has filed industrial entrepreneurs' memorandum on September 2020.
